Sub: Request for issuing an intra-circle transfer order of officers for soft tenure Station in the OTP Portal.

Respected sir,

With respect to the above-cited subject in the Gujarat circle, many officers have completed their soft tenure, and though they are registered in the OTP portal, their transfer orders have not been issued to date. Any officer who transfers to a soft tenure station is experiencing hardship and expects to be relieved immediately upon completion of the tenure period.

If transfer and release orders for soft tenure stations are issued on time and strictly followed, it will be easier to implement the issued administrative orders, and officers will be able to join new places of posting in soft tenure stations without hesitation.

To avoid the officer's hardship, Corporate Office Letter No. BSNLCO-PER1/20/11/3/2020-PERSI dated November 9, 2022 requests that transfer and posting orders may be issued for such officers before the end of their soft tenure period based on OTP requests.

In the Gujarat circle, many officers completed their soft tenure and registered in the OTP portal but still continue to face hardship, are highly demotivated, and eagerly await their orders.

Hence, I request your good office to issue a transfer and posting order for all officers who have either completed their soft tenure or are on the verge of completing soft tenure.

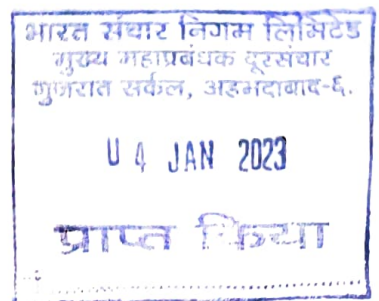

Ref: This office letter No. BSNLCO-PER1/20(11)/3/2020-PERS1 Dated: 03.01.2022

In continuation of this office letter under reference conveying the decision to implement OTP for Intra Circle Transfer of executives (JTO level & above, of all streams) **with effect from 1st January, 2022**, your kind attention is hereby invited to the clause 6 stipulating that "No manual applications for request transfer shall be considered" and it is once again requested to ensure that no request based Intra-Circle transfer are done on the basis of manual applications. All the request based Intra-Circle transfers must be based on online requests received in the OTP only.

Also, since OTP window is now opening biannually, thus to curtail the hardship to the officers undergoing SOFT TENURE posting in the circles who are at the verge of completion of SOFT TENURE, the transfer and posting orders of such officers may kindly be issued before completion of their SOFT TENURE period on the basis of requests received through OTP, with a mention in the transfer order that the officer may be relieved from the SOFT TENURE station only after completion of the SOFT TENURE.


In this regard, I have been directed to request you to submit a Certificate (as per Performa attached at Annexure-I) to this office by 15th Nov, 2022 on the e-mail ID – dm4pers1@gmail.com.
