It has also been observed that concentration of executives at some preferred locations are more than desired which results in shortage of executives at less preferred locations.

The total stay in SSA of the executives has been counted including the stay under the previous cadres/grades irrespective of the category (executive/non executives). A list of 25 AOs and 22 JAOS having BA/SSA tenure stay more than 19 years & 10 years are enclosed herewith as Annexure A & B respectively. If any executive covered under immunity, medical ailment as detailed in BSNL transfer policy, the same shall be intimated to this office through BA Admin by 25.03.2023. All such applications received through OTP should be forwarded to GM(HR/Admn), Circle Office, Ahmedabad.
